### **Institutional preparedness for NEP**

1. Multidisciplinary/interdisciplinary:

This new approach, known as the multidisciplinary or interdisciplinary approach, enables students to explore and study different subjects or curricula from different fields. The institute has adopted the Choice-Based Credit System (CBCS) pattern for its UG and PG courses from the academic year 2016-17. In the same year, the parent university introduced Skills Enhancement Course and made it compulsory for all the affiliated colleges at UG Second and Third Year. The student has the option to opt for any of the subjects as their skill enhancement course. Besides, it has taken hard efforts in existed inter / multidisciplinary research to transform itself into a holistic multidisciplinary institution. Environmental

	Science is a compulsory subject for third-year students. The college is ready to work according to the NEP-2020 Guidelines and to start new courses as per the interest of the learner.
2. Academic bank of credits (ABC):	As the National Bank of ABC is integrated into the ned.digitallocker.gov.in and online platform which was currently live for the academic year 2021. The preparedness of the institution in implementation of ABC as per the guidelines issued for the same by the affiliated university and higher education department from time to time. ABC has been implemented in our institution from the academic year 2022-23.
3. Skill development:	The college is already conducting the skill courses as designed by the affiliated university from semester 3 to 6 in all UG programs of humanities, Arts and Commerce. Skill Enhancement course is carried out through theoretical course and project work as directed by the affiliated university.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	In our college, students are taught using the Indian language, and many cultural activities are done so that they can be made aware of our culture. Three language departments Marathi, Hindi, English - have classical literature of India into their core syllabi also many cultural programs were conducted by our college like Independence Day, Republic Day celebration, Makar Sankranti, Raksha Bandhan in the college.
5. Focus on Outcome based education (OBE):	Our Institution offers 2 UG, 1 PG (Regular History), 6 PG (Distance Mode) and 2 research programs in the campus. Keeping in mind the regional and global requirement, all these programs are designed to offer outcome-based education. The institution has implemented outcome -based education with clearly stated programme Outcomes, Programme specific Outcomes and Course outcomes of the affiliating University. The course Objectives are also aligned with due consideration to macro-economic and social needs at large so as to apply the spirit of NEP.
6. Distance education/online education:	Our college also provides Distance Education facilities for PG Courses like M.A. Courses in English, Hindi, Marathi, Political Science, Public Administration and Economics (Distance Learning Programme) recognized by Swami Ramanand Teerth Marathwada University, Nanded. Various online tools like Zoom, Google meet, Telegram and

WhatsApp are utilised during the pandemic and post covid-19 situation. Almost all departments have used online platform for teaching learning.

Yes, the college established the Electoral Literacy Club. Electoral Literacy Club is set up in the college to promote electoral literacy. Our Electoral literacy activities aim at strengthening the culture of electoral participation among young and future voters. Our college has taken conscious efforts to create awareness among students regarding Electoral process. Electoral Literacy Club works with the following objectives: 1. To enhance the potential of ELC members for carrying the electoral literacy in communities. 4. To educate the target groups about voter registration, electoral process. 5. To acquaint participants about Electronic Voting Machine (EVM) and Voter Verifiable Paper Audit Trail (VVPAT) and educate them. 6. To facilitate voter registration for its members as they attain the age of 18.

## 6.4 Financial Management and Resource Mobilization
